**Section I.** The following individual is hereby re-appointed to the Indian Head Community Activities Committee for 3-year terms of office as noted below:




**Section II.** Be it further resolved that all resolutions or parts of resolutions in conflict herewith be and the same are hereby repealed to the extent of such conflict.
