A RESOLUTION TO ENDORSE A DEMOLITION PROJECT TO BE UNDERTAKEN BY THE CHARLES COUNTY CHAMBER OF COMMERCE MILITARY ALLIANCE COUNCIL.

WHEREAS, the Indian Head Town Council recognizes that there is a significant need for reinvestment and revitalization of the communities in and around the Town of Indian Head; and

WHEREAS, the Town of Indian Head has been designated as a Sustainable Community; and

WHEREAS, the Charles County Chamber of Commerce Military Alliance Council ("MAC") proposes to implement a Demolition Project as described in an Application ("Application"), to contribute to the reinvestment and revitalization in the Sustainability Community Area; and



WHEREAS, the MAC intends to obtain some or all of the financing for the Project in the form of a grant or loan in an amount up to \$550,000 ("Project Financing") either directly through the Department of Housing and Community Development of the State of Maryland or through other departments or agencies of the State of Maryland in order to make the Project financially feasible; and

WHEREAS, the Project is located within a priority funding area under Section 5-7B-02 of the Smart Growth Act and will conform to the Town zoning code; and

WHEREAS, the applicable law and State department and agency regulations require the Town to approve the Project and Project Financing;

NOW THEREFORE, BE IT HEREBY RESOLVED by the Town Council of Indian Head, Maryland, that:

1. The Town Council hereby endorses the Project and Project Financing as described in the Application.
2. The Mayor, as the chief elected executive official of the Town, is hereby requested to endorse this Resolution, indicating his approval by signature hereof.
3. The following persons are hereby authorized to execute documents and take any action necessary to carry out the intent of these resolutions;
