Minutes: September 8th Town meeting minutes and September 23rd work session minutes. Vice Mayor Sitoula made a motion to approve the minutes as presented, Mayor Paulin seconds the motion. The minutes were approved as presented by voice vote: 3-Ayes, 0-Nays.

Reports of Officers, Boards and Committees:

- A. Permits** – The permits report for September was read. (See attached)
- B. Finance Report** – No report. The finance report for September will be read at the November meeting.
- C. Town Manager's Report** –Please have your trash curbside by 7:30am on the day of your scheduled pick up. The Boardwalk pre-construction meeting and the groundbreaking ceremony were held on September 17th. Construction to begin soon. The Town is responding to the Maryland State Highway Administration (MDSHA) review comments on the Village Green restroom project. The Town needs to schedule the final review meeting with MDSHA. The Town is working on the Sustainable Communities application to renew the Town's designation which expires in May 2021. Town owned playgrounds are open. Mattingly Park picnic pavilion remains closed. The Town Hall reopened on September 14th with operational hours of 8:30am to 4:30pm. Hours are subject to change based on COVID. The Town's engineer is in the process of finalizing the Comprehensive Plan for Planning Commission review before presenting it to the Town Council. Town Manager Hicks has spoken with Wendi Peters, Special Secretary for Maryland Smart Grown about funding opportunities for East Poplar Lane stormwater issues. Discussions are ongoing. Building codes are currently being placed in Ordinance form so that the Town can adopt the most recent code updates. The Town hopes to have them included on the November Town meeting agenda. The Zoning ordinance public hearing will be held on November 2nd at 6pm prior to that evening's Town meeting. The Velocity Center

grand opening was held on September 17th. The leaf vacuum will begin on November 4th. Work has begun on the CIRI property's new development behind the Villages of Potomac. Earth work began last month.

- D. Code Enforcement Report** – The Town issued 74 notices of violation for the month of September. 41 grass & weeds violations, 9 grass & weeds fines, 13 rubbish and garbage violations, 3 rubbish & garbage fines, 6 property maintenance violations, 1 property maintenance fine and 1 property maintenance citation. The Town completed 11 rental inspections and cleared 41 violations for the month of September.
- E. Planning Commission Report** – The September Planning Commission meeting was canceled.

Unfinished Business: Mayor Paulin gave an update on parks & pavilion usage. The parks are fully operational except for the Mattingly Park Pavilion remains closed. Pavilion usage is permitted if renters have a COVID plan in place and follow all COVID guidelines/ Governor's protocols.

New Business: The Town Council authorized its engineer, ARRO Consulting, Inc, to develop a proposed Zoning Ordinance and Zoning Map revision. An electronic copy of the proposed Zoning Ordinance and Zoning Map revisions are available on the Town's website, www.townofindianhead.org. The Town Council received a recommendation from the Planning Commission to approve/adopt the revised Zoning Ordinance & Zoning Map. A hearing to present the proposed Zoning Ordinance & Zoning Map revisions to the public, will be held on Monday, November 2, 2020 at 6:00pm, prior to that evening's Town meeting on the GoToMeeting platform. Questions and/or concerns from the public will be addressed at the hearing by a representative of ARRO. Residents who are unable to

attend the public hearing will have until October 26, 2020 to submit their comments which will be read under the public comment portion of the hearing agenda.

Mayor Paulin gave an update on Town name change request from the Piscataway Conoy Tribe. Mayor Paulin spoke with Tribal Chair, Francis Gray. The Tribal government of the Piscataway Conoy have differing views of the few members who started the petition. Mr. Gray has been invited to come speak before the Council at a future meeting. Mayor Paulin and Mr. Gray also spoke about the Town and the Tribe working together on developing a new Town seal.

Miscellaneous: Mayor Paulin read the upcoming events and meetings for October. (see attached)

Citizen's Comments: Councilman Albright asked for additional information on Mr. Gray's opinion on the requested name change. Mayor Paulin's understanding from the conversation held with Mr. Gray was that the majority did not feel that way about the name. Mr. Gray plans to discuss this at his next Tribal government meeting to get a more definitive understanding of everyone's position. It was Mayor Paulin's understanding that the petition was not the view of the whole Piscataway Conoy Tribe. Mr. Gray, having grown up in Western Charles County understands why the Town has its name. That the name comes from the area being the Indian Headlands.


Vice Mayor Sitoula suggested looking for a recommendation from MD Historical Trust. Mayor Paulin said Mr. Gray also spoke about education since a lot of people do not really know about the Piscataway Conoy in the area. Mayor Paulin would like the Town to partner with Mr. Gray and the MD Historical Trust to work on outreach to educate people.
