WHEREAS, the Town of Indian Head has partnered with local organizations to help keep our town parks: safe, clean and beautiful through the Adopt-a-Park program;

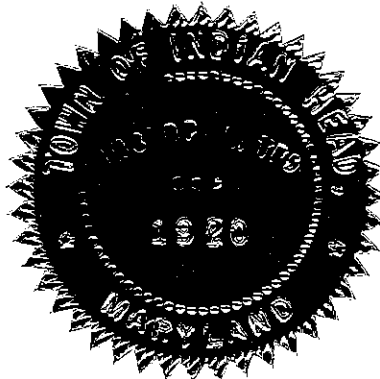

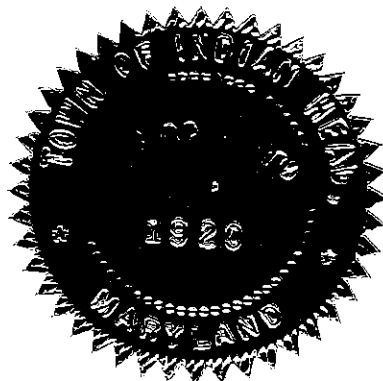
