**A Resolution regarding** the Town of Indian Head being included in the Study Area for a Joint Land Use Study (JLUS) for Naval Support Facility Indian Head.

WHEREAS, Council of the Town of Indian Head recognizes that the Town of Indian Head has been included in the Study Area for a Joint Land Use Study (JLUS) for Naval Support Facility (NSF) Indian Head, located in Charles County, Maryland, since operations at this Facility can potentially affect land and water uses in Indian Head; and

WHEREAS, the purpose of a JLUS is to encourage cooperative land use planning between military installations and the surrounding communities so that future civilian growth and development are compatible with the training, test, or operational missions of the installation; and to seek ways to reduce operational impacts on adjacent lands; and

WHEREAS, the Council of the Town of Indian Head agrees to participate in the NSF Indian Head JLUS in an advisory capacity to assist in identifying issues and formulating policies and an action strategy to promote compatibility between Indian Head and NSF Indian Head; and

WHEREAS, the other local government participants in the NSF Indian Head JLUS include Charles County, Maryland, as study sponsor.

WHEREAS, the Council of the Town of Indian Head recognizes that participation in an advisory capacity in the NSF Indian Head JLUS will benefit the health, safety, and general welfare of the residents of Indian Head and Charles County; and

WHEREAS, no commitment of Town of Indian Head funds are required of being made, as this JLUS is being sponsored by the County Commissioners of Charles County, Maryland, who will apply for the grant assistance to support the cost of the JLUS, and be responsible for the required match and other related study management functions.


NOW, THEREFORE, BE IT RESOLVED, by the Indian Head Town Council as follows:


1. The Council of the Town of Indian Head agrees that the Town of Indian Head will participate in an advisory capacity in the development of a JLUS for NSF Indian Head.


