<u>Minutes</u>: March 6th Town meeting minutes and March 29th work session minutes. Councilman Smith made a motion to approve the minutes as presented; Vice Mayor Sitoula seconds the motion. The minutes were approved as presented by voice vote: 3-Ayes, 0-Nays.

Reports of Officers, Boards and Committees:

- A. Permits –The permits report for March 2017 was read (attached).
- B. Finance Report The finance report for March 2017 was read (attached).
- C. Town Manager's Report Please have your trash curbside by 7:30am on the day of your scheduled pick up. New members are still needed for the Board of Zoning Appeals, Planning Commission, Ethics Commission, Parks and Rec Commission and Environmental Sustainability Committee. Please contact the town hall if you would like a new 95 gallon toter for recycling for your home or place of business. Online bill pay will be up and running at the next billing cycle. Paving repairs will take place along Strauss Avenue, Raymond Avenue and Jenkins Drive this week. The Town is applying for a Chesapeake Bay trust grant to do work in Mattingly Park. The Town is still awaiting word from the State as it relates to the new funding request. A quote from the most recent response, "Thank you for reaching out for an update on this project. Unfortunately, the letter is still under review by senior management. We are actively tracking this review so that when a decision is made we can forward that information to you." The budget process is well underway and the public hearing on the budget will be held on Thursday April 13th at 7pm. If you would like to sign up for dual billing please fill out a form which can be located on the Town's website and at the Town Hall. The Town will be removing several dead trees this week along Riverwatch Drive and Jennifer Drive to name a few locations. The tree issues are a result of the recent storm. The fountain on the Village Green and the bathrooms at Mattingly Park are both in operation for the season.
- **D.** Code Enforcement Report The Town issued 6 notices of violation during the month of March 2017. 1 property maintenance violation, 1 vacant structures & land violation, 2

- vehicle violations, 1 rubbish & garbage violation and 1 open burning violation. The Town performed 2 rental inspections for the month of March 2017.
- **E.** Planning Commission Report The Planning Commission voted to recommend Council approval of the CIRI zoning map amendment request with conditions.
- F. Parks and Recreation Report Councilman Smith reported that the P&R Commission will start having robotics and video game design classes at the Senior Center on Saturdays. P&R recently purchased shirts for the dance program and they are working on getting outfits as well.
- G. Environmental Sustainability Report Councilman Smith reported that on Saturday, April 8th, the ESC will take part in the annual watershed cleanup at Mattingly Park from 10am to 2pm. Volunteers are needed and lunch will be provided by the Town.
- F. Bureau of Fire Prevention Chief Williams reported that for the month of February, the IHVFD responded to 33 fire responses, 15 first due, 18 mutual aid and 23 medical responses. The IHVFD also completed 100 hours of training. For the month of March, the IHVFD responded to 23 fire responses, 11 first due, 12 mutual aid and 29 medical responses. The IHVFD also completed 125 hours of training. During the recent storm the IHVFD received a lot of calls for trees down. If there is a person whose life is in immediate danger as a result of the tree, the fire department will do everything they can. They cannot remove trees but they will do everything they can to save individuals. Chief Williams also reminded people to be careful of hazardous chemicals during spring cleaning and take advantage of the County's hazardous waste disposal services.

Briefings: Paola Addamiano-Carts, Chairperson, Kids Into Discovering Science (KIDS):Ms. Addamiano-Carts shared information on her local nonprofit STEM program including the background on the program and information on some of the student participants. The program currently has 35 kids involved and they are an even mix of Prince George's County residents and Charles County residents as well as public, private and homeschooled children. The STEM program has a robotics team and a human powered submarine team. They also do fieldtrips and STEM outreach. More information is available on the KIDS website and Facebook page. Registration is \$100 per family with up to 2 children and a waiver is available for families who cannot afford the \$100 registration fee. KIDS meet every Friday night and their membership cycle starts in August.

Corey Ramsden, Program Director MD Sun – Solar Co-op: Mr. Ramsden shared information on MD Sun Solar Co-op. MD Sun and communities work together to form solar co-ops and they provide the technical and administrative support. MD Sun also creates a co-op website and administrates sign up process and responds to technical inquires. They also present at info sessions, facilitate RFP processes, installer selection and installer management. For more information you can contact Mr. Ramsden at corey@mdsun.org or 240-334-7720.

William Price, Bryant Mitchell Architects: Mr. Price presented the New Life Christian Ministries concept plan for repurposing, refurbishing and redeveloping the Ely shopping center, law office and warehouse. Currently the plans include a grocery store, retail stores, a daycare, a playground, a religious assembly and conference space and a possible Sheriff's department substation. Mr. Price showed current photos of the Ely properties, proposed floor plans and discussed the phases of construction. New Life Christian Ministries has spoken with a developer and they are looking for community input and support for the project. Town Manager Hicks did clarify that the project would not need approval or zoning from the County since it is within the Town of Indian Head.
